a. Firefighters Inc.: Nothing at this time

b. Fire Inspector:

Admin. Assist. Oborne has finished going through Fall of 2022 fire inspections. Updated business contact information for Inspection Services. Referred inspections and No Entries were given to the Fire Chief for follow-up. Spring inspections have started.

2022 final numbers -324 total inspections, 8 occupancies with violations noted(includes those corrected or referred, 3 occupancies with outstanding violations, 5 occupancies with violations noted and corrected on scene.

Fee Changes for 2023-Fire Inspections raised from \$44 to \$45 per inspectable occupancy per year for semi-annual fire inspections. Fire inspections of seasonal occupancies raised from \$32.00 to \$32.50 per inspectable occupancy.
